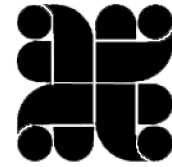

PLEASE READ THE FOLLOWING CAREFULLY BEFORE FILLING OUT THE APPLICATION

ART IN THE PARK ELIGIBILITY: ONLY original work, handmade by the artist named on the application. Items made strictly by a process, with little or no artistic merit, may not be accepted. (No molds, kits, stamps, pre-packaged food, doll clothes, ceramics from molds, etc. No items contracted out and/or made by someone else, or items purchased for resale). Enough work should be brought to sell for both days. Failure to return the second day, leaving early or setting up late will result in ineligibility for future shows. Every applicant goes through the jury process every year. We pick the best of all applying artists. The Art in the Park jury committee reserves the right to reject any application.

MEDIA CATEGORIES: Show open to most media.

BOOTH SPACE AND FEES: Space fees \$150 for a 12'x12' space. A non-refundable jury fee of \$25 will be required in a separate check. Make checks payable to AAAA-Art in the Park. Exhibitors must provide their own means of display, including tables and chairs. Spaces are not transferable. No food or drink may be sold from your booth. Be prepared for rain and/or wind. **If booth is larger than 12'x12' in any direction, you will be charged accordingly.**

APPLICATION: INCLUDE 1) 4 digital images (.jpg format; smallest possible resolution) representing work to be exhibited must be provided on a CD included with the application. 2) Booth fee and jury fee. 3) Signed application form. Only those items listed in your application and represented in your digital images, which have been approved by the Review Committee, may be displayed and sold. Failure to comply may result in your being asked to remove items or, in some instances, to leave the show with no refund.

ENTRY DEADLINE: Applications must be postmarked no later than midnight on MAY 1, 2010 in order to be considered. Notices of acceptance/rejection will be mailed out in mid-May.

REVIEW COMMITTEE: Selection will be based on artistic merit, originality, creativity, craftsmanship and the quality of entries in a particular category. Good quality images (close-ups of individual items, with each medium represented) are very important.

REFUND POLICY: If notice of cancellation is received in writing, with a postmark on or before midnight JUNE 1, 2010, a full refund of the booth fee will be given.

NO REFUND after this date, though notice of cancellation is required.
